

ADDENDUM TO CORPORATE LICENSE AGREEMENT

This Addendum amends and supplements the Corporate License Agreements No 134504-C490404 and 131983-C330404 ("CLA") between Kommentus Gruppen AB ("Prime Customer") and Novell Svenska AB ("Novell"). This Addendum is made between [name] ("Member") and Novell. Member is a member of the CLA under membership number [XXXXXXXXX].

This Addendum shall be effective only upon its signature by Novell, which shall follow signature by Member.

WHEREAS:

- (A) Prime Customer and Novell have entered into the CLA.
- (B) Member has joined the CLA as a member under the above mentioned membership number.
- (C) Novell has made a special promotion only available to members of the CLA as follows:
 - (i) Members may purchase licenses and use Selected Products on a Workstation License basis (see below for definition) for the period allowed by this offer as stated below.
 - (ii) In order to do this, Prime Customer or Member wishing to participate in this offer must purchase licenses of at least TWO of the Selected Products and also full term Upgrade Protection for all such licenses.
 - (iii) For those Members that have already purchased licenses of the Selected Products, they may convert their existing license basis to Workstation License basis by purchasing full term Upgrade Protection for all licenses they already own for at least TWO of the Selected Products and by signing this Addendum.
 - (iv) The Workstation License will continue for the period of the full term Upgrade Protection. At the end of that period, Member shall have the option to (a) continue on a Workstation License basis by buying full term Upgrade Protection again for those licenses or (b) converting to standard licenses at which point the conversion rules stated below will apply.
- 1 <u>DEFINITIONS</u>. Terms with the initial letter capitalised will have the same meaning as defined in the Agreement, unless otherwise defined in this Addendum.
 - 1.1 "Workstation" means any computer, including laptops and/or devices, using one or more of the Selected Products listed below, within Member's organization, regardless of whether such computer, laptop or device is owned, leased or otherwise controlled by Prime Member or Member or their contractors performing work on the premises of Prime Member's or Member's organization. Workstation does not include a dumb terminal attached to a mainframe that is not connected to a network using Novell Software.
 - 1.2 "Selected Products" means NetWare, Zen for Desktops, Zenworks Suite and GroupWise in any version and language.
- 2 AMENDMENTS TO AGREEMENT. The Agreement is amended and supplemented as follows:
 - 2.1 <u>Workstation License Option</u>. Novell makes available to all Members that meet the conditions stated in this Addendum the right for that Member to use the licenses as Workstation Licenses. For those Members that do not already own licenses of the Selected Products (at least two), they may purchase such licenses as if one Workstation was one User.
 - 2.2 <u>Conditions.</u> Members will qualify for the Workstation license option if they sign this Addendum and meet the conditions as follows:

- 2.2.1 Members wishing to participate in this offer must purchase licenses of at least TWO of the Selected Products and also full term Upgrade Protection for all such licenses.
- 2.2.2 For those Members that have previously purchased valid licenses of the Selected Products, they do not need to purchase additional licenses (unless they need additional licenses), and they may convert their existing license basis (which is User) to Workstation License basis by purchasing full term Upgrade Protection for all licenses they already own for at least TWO of the Selected Products. The conversion rate shall be one User license is equivalent to one Workstation License.
- 2.2.3 The Workstation License will continue for the period of the full term Upgrade Protection. At the end of that period, Member shall have the option to (a) continue on a Workstation License basis by buying full term Upgrade Protection again for those licenses or (b) converting to standard licenses at which point the conversion rules stated below will apply.
- 3 RENEW/EXIT. At the end of the full term Upgrade Protection, the Workstation License shall convert to User license again at the rate of one Workstation License shall provide one User license. Alternatively, Member can choose to continue the Workstation License by again purchasing full term Upgrade Protection for all licenses that it has for at least TWO of the Selected Products and again signing this Addendum at that time.
- 4 **PRICING.** All pricing for licenses and full term Upgrade Protection shall be as negotiated between Member and its authorised CLA partner.
- 5 <u>CONTINUANCE</u>. Except as expressly amended and supplemented by this Addendum, the terms and conditions of the CLA will remain in effect unchanged.
